Essential Job Functions

- Manage the City of Santa Fe Volunteer Trail services contract under the supervision of the Executive Director.
- Establish and implement a "needs assessment" for stewardship purposes
 of the official natural surface trails within the limits of the City of Santa Fe
- Recruit, train and manage a volunteer team of regular trail stewards
- Assess and set priorities as to which trails need maintenance
- Organize, publicize and manage at least four major and several minor "work events" each year
- Act as the SFCT liaison and coordinate with City officials and departments to deliver services
- Coordinate with local interest groups (Trails Alliance, Fat Tire Society, Sierra Club, etc) to optimize trail stewardship and involvement
- Provide monthly progress reports of all trail stewardship activity
- Conduct public outreach activities to promote the City of Santa Fe Trails System.

- Bachelor's degree with a minimum of two years' experience in trail stewardship activities.
- Familiarity with word processing, spreadsheet, database, email, and other office software; knowledge of Acrobat, ArcInfo and/or web design software a plus.
- Strong interpersonal, organizational, multi-tasking, negotiation and analytical skills with the ability to work independently within a team.
- Maturity, self-confidence, humor, flexibility, interest in acquiring new skills, professional manner, cultural sensitivity, and a friendly, problem-solving personality.

- Licensed to operate a motor vehicle and experience in using a variety of common trail building and maintenance tools
